# 1. BACKGROUND INFORMATION

## 1.1. Contracting Authority

## 1.2. About the organization

"Together for Life" (TFL) association is a non-political, non-governmental and not-for-profit organization, established in late 2009 as an initiative of a group of reputable journalists as a membership organization; focusing on the development and empowerment of people. TFL has undertaken a range of innovative and successful projects and activities. It has gained reputation as the first and most prominent organization dealing in health rights in the country; as well as has expanded its activity to promote the debate on the building of civil society and a culture of human rights in Albania; with a focus on vulnerable communities; communities living in remote or economically less advantaged areas; women and youth. Together for Life Organization (TFL) since its inception is playing an active role socio-economic betterment and cultural development of the society through a rights-based approach. TFL has successfully managed and implemented project on human rights, patients' rights; labor rights; economic empowerment and good governance and achieved remarkable milestones.

## 1.3. About the TFL project

Since January, 2021, TFL is implementing in Albania the project "Reintegration of the Returnees by increasing access to health care and improving their health", funded from the GIZ.

"Together for Life" organization aim to protect of the returnees from further deterioration of their health, age, gender and diversity, equity in access to health care, sustainability of the action and community empowerment to advocate for better health care. People with a chronic disease have a reduced working capacity and opportunity in Albania. Staying at home and not contributing to the household finances, increases the financial burden for their families and communities. Through integrated approaches, the project will address health care issues of the returnees, that are declared as obstacles for their reintegration into society and will support their integration.

The project is conceptualized in three phases that proceed in parallel:

Firstly, to identify health-related factors and barriers faced by the returnees are identified and brought to the attention of the respective institutions.

Secondly, to increase the capacities of 20 general practitioners and representatives of labour offices in Lezha and Elbasan.

Thirdly, to increase the access to basic health care and psychosocial services up to 30 returnees.

# 2. OBJECTIVE, PURPOSE & EXPECTED RESULTS

## 2.1. Overall objective

The Objective of the assignment is:

We are looking for one migration expert to work on this assignment "The national politics for reintegration of returnees into society". The training will be conducted in Elbasan and Lezha.

The goal of this activity is to enhance capacity and knowledge of the two groups participants of the primary care doctors and employees of the immigration, on the topics of: international migration legislation, national migration legislation, the referral system, the obstacles for returnees reintegration, reintegration legislation and responsibly institutions.

Training primary care doctors and employees of the immigration counter in Elbasan and Lezha, on effective ways and means to support returnees with quality services. The training will focused to information of the primary system workers and migration expert on job centers, for about emigration problems and their needs for support after returning.

The module will focus on increase the capacities of health providers and labour administration to address barriers to returnee services.

The module will include, but not suffice with providing information about:

- National and international legislation in the migration field;
- Government policy for migration and and returnees integration in Albania;
- The rol and responsibility of the national and local institutions to provid the services and assistance for the returnees;
- The need to support returnees integration.

The expert will work closely, in consultation and coordination with the project team.

The expected results and deliverables of this assignment are:

**Result(s):**

1. Emphasize importance of increase services access for returnees in the project area.
2. Increase knowledge and capacities of 20 persons - general practitioners/family doctors and representatives of Labour Offices (10 in Elbasan) and (10 in Lezha) in regard with need to integrate of returnees in health care sistem.
3. Stimulate discussions in identifying challenges and problems in regards to returnee services in the Lezha and Elbasani areas.
4. Provide practical and concrete demonstration of how to providing and offering the best services for returnees as an important element for their integration.

**Deliverable(s):**

The expert(s) in consultation with project team members, will ensure the submission of the following materials by the deadlines given:

- a) Document with the specific information regarding legal frame work for migration and reintegratin in Albania.
- b) An Agenda and A Power Point presentation used during training delivery.

The expert(s) will conduct the following activities:

1. Become familiar with the Project “Reintegration of the Returnees by increasing access to health care and improving their health”

  - a. Develop and finalize the agenda for the training program based on the number of days agreed in collaboration with health expert.
  - b Design the following:
    - The training materials including document and handouts and standard power point presentations.
3. Facilitate the training course based on the agreed agenda, objectives, and outputs as well as in accordance with the standards of professional competence and ethical integrity. The expert will make use of the information presented in the Feasibility Study document.
4. Prepare a short brief report for the training course also including assessment of participants’ evaluations. The participants’ evaluations should review training content, methods and conduct, practical exercises, and logistical arrangements.
